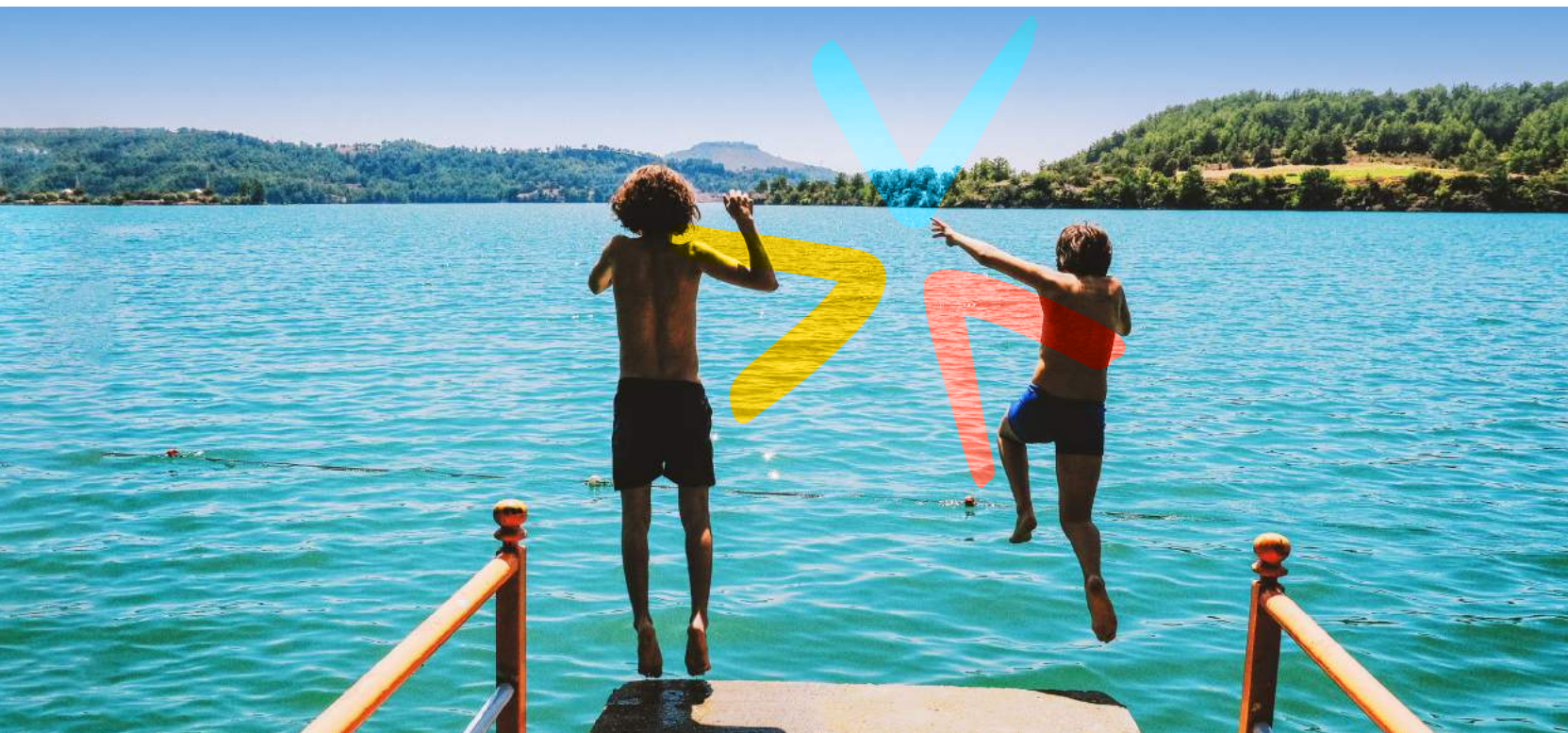




Vacanceselect announces the appointment of Nicolas CHANDOU as Chief Financial Officer and member of the Group Management Board

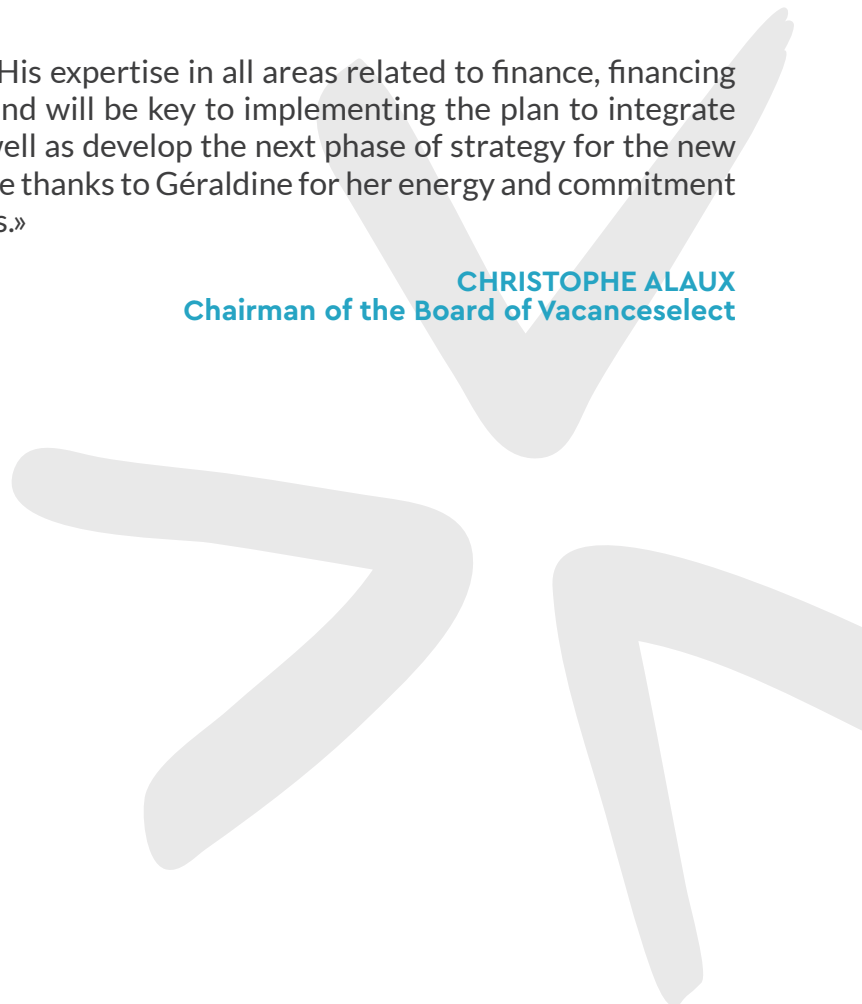
Nicolas CHANDOU holds a Master Degree (DESS) in Corporate Finance and Financial Engineering from the University of Paris IX-Dauphine.
